Agreement General Conditions

Updated: 21 October 2021

NFT Panda World of Fantasy is a distributed application that runs on the WAX blockchain, using specially-developed smart contracts (each, a “Smart Contract”) to enable users to own, transfer, and send on adventure digital pandas, which can then be visualized on a website that the user can interact with (the “Site”). The Smart Contracts and the Site are collectively referred to in these Terms as the “App”. Using the App, users can view their pandas and use the Smart Contracts to acquire, trade, and send on adventure.

Provider of NFT Panda World of Fantasy - PE Lakatosh I.I. ("NFT Panda team", "NFT Panda World of Fantasy", "we", or "us") is making the App available to you. Before you use the App, the Smart Contracts, or the Site, however, you will need to agree to these Terms of Use and any terms and conditions incorporated herein by reference (collectively, these "Terms"). PLEASE READ THESE TERMS CAREFULLY BEFORE USING THE APP, THE SMART CONTRACTS, OR THE SITE. THESE TERMS GOVERN YOUR USE OF THE APP, THE SMART CONTRACTS, AND THE SITE, UNLESS WE HAVE EXECUTED A SEPARATE WRITTEN AGREEMENT WITH YOU FOR THAT PURPOSE. WE ARE ONLY WILLING TO MAKE THE APP, THE SMART CONTRACTS, AND THE SITE AVAILABLE TO YOU IF YOU ACCEPT ALL OF THESE TERMS. BY USING THE APP, THE SMART CONTRACTS, THE SITE, OR ANY PART OF THEM, OR BY CLICKING “I ACCEPT” BELOW OR INDICATING YOUR ACCEPTANCE IN AN ADJOINING BOX, YOU ARE CONFIRMING THAT YOU UNDERSTAND AND AGREE TO BE BOUND BY ALL OF THESE TERMS. IF YOU ARE ACCEPTING THESE TERMS ON BEHALF OF A COMPANY OR OTHER LEGAL ENTITY, YOU REPRESENT THAT YOU HAVE THE LEGAL AUTHORITY TO ACCEPT THESE TERMS ON THAT ENTITY’S BEHALF, IN WHICH CASE “YOU” WILL MEAN THAT ENTITY. IF YOU DO NOT HAVE SUCH AUTHORITY, OR IF YOU DO NOT ACCEPT ALL OF THESE TERMS, THEN WE ARE UNWILLING TO MAKE THE APP, THE SMART CONTRACTS, OR THE SITE AVAILABLE TO YOU. IF YOU DO NOT AGREE TO THESE TERMS, YOU MAY NOT ACCESS OR USE THE APP, THE SMART CONTRACTS, OR THE SITE.

1. CHANGES TO THIS AGREEMENT

NFT Panda World of Fantasy reserves the right to change or add to these Conditions at any time, without notifying the User. If the User does not agree to the Conditions, NFT Panda World of Fantasy reserves the right to terminate the Agreement, which leads to the deletion of the User’s account.

2. THE APP

To most easily use the App, you may first create WAX account and an electronic wallet compatible with the Non-Fungible Token (NFT) standard on the WAX blockchain, such as the WAX Cloud Wallet electronic wallet accessible <https://wallet.wax.io/>. WAX Cloud Wallet and other electronic wallets allow you to purchase, store, and engage in transactions using WAX cryptocurrency. You will not be able to engage in any transactions on the App other than through WAX-compatible wallets.

Transactions that take place on the App are managed and confirmed via the WAX blockchain. You understand that your WAX public address will be made publicly visible whenever you engage in a transaction on the App.

We neither own nor control WAX Cloud Wallet, Google Chrome or other browsers, the WAX blockchain, or any other third party site, product, or service that you might access, visit, or use for the purpose of enabling you to use the various features of the App. We will not be liable for the acts or omissions of any such third parties, nor will we be liable for any damage that you may suffer as a result of your transactions or any other interaction with any such third parties.

3. GAME TOKEN AND PANDAS

The BAM (Bamboo) token is used to encourage players' activity in the game. Bam token issued on WAX blockchain via smart contract. Adventure is a function in a smart contract, designed in the user interface on a website, which pseudo-randomly, taking into account the rarity of your panda and other features, rewards the user in BAM tokens.

Each Panda is an NFT (Non-Fungible Token) on WAX blockchain. You Own the NFT. When you purchase a Panda, you own the underlying NFT completely. This means that you have the right to trade your NFT, sell it, or give it away. Ownership of the NFT is mediated entirely by the Smart Contract and the WAX blockchain: at no point will we seize, freeze, or otherwise modify the ownership of any Panda.

In case of violating the rules of this Agreement, which leads to the further blocking/deleting of the User's account, a User will not be able to withdraw BAM. Users can get a BAM token after sending Panda on an adventure.

4. PROHIBITED ACTIVITIES

You may not access or use the Site and Smart Contracts for any purpose other than those for which we make the Site and Smart Contracts available. The Site and Smart Contracts

cannot be used in connection with any commercial endeavors, except as agreed with the management of NFT Panda: WoF.

Systematically retrieve data or other content from the Site and Smart Contracts to create or compile, directly or indirectly, a collection, compilation, database or directory without the permission of the NFT Panda: WoF guide.

Use offline shopping mechanisms associated with the NFT Panda: WoF brand.

Use the Site and Smart Contracts to advertise or sell goods and services.

Bypass, disable or otherwise interfere with the security-related functions of the Site and Smart Contracts, including features that prevent or restrict the use or copying of any Content, or impose restrictions on the use of the Site and Smart Contracts and / or the Content contained therein. Participate in the unauthorized creation or placement of links to the Site and Smart Contracts. Deceive or mislead us and other users, try to find out any confidential information. Use our support services inappropriately or send false reports of abuse or misconduct. Participate in any automated use of the system, for example, use scripts to post comments or messages, or use any data mining, robots, or similar data collection and extraction tools, except as agreed by the management of NFT Panda: WoF. It is forbidden to use multiple accounts by one person, the so-called multi-accounts and bots. Suspicious actions will be monitored and sanctions will be applied to violators of the rules of this agreement. Interfere with, disrupt or create undue load on the Site and Smart Contracts or networks or services connected to the Site. Try to impersonate another user or person, or use another user's username. Sell or otherwise trade your profile. Use any information obtained from the Site and Smart Contracts to harass, insult or harm another person. Use the Site and Smart Contracts in competition with NFT Panda: WoF or otherwise use the Site, Smart Contracts and / or Content. Decrypt, decompile, disassemble or reverse engineer any software that is or in any way forms part of the Site and Smart Contracts. Try to circumvent any measures of the Site designed to prevent or restrict access to the Site or any part of it and Smart Contracts. Harass, intimidate or threaten any of our employees or agents involved in providing you with any part of the Site and Smart Contracts. Remove any mention of copyright or other proprietary rights in any way. Copy or adapt the software of the Site, including Flash, PHP, HTML, JavaScript or other code.

Upload or transmit (or attempt to download or transmit) viruses, trojans or other materials, including excessive use of capital letters and spamming (continuous publication of repetitive text), which interferes with the continued use of the Site or alters, degrades, disrupts or interferes with the use, functionality, operation or maintenance of the Site and Smart Contracts. Upload or transmit (or attempt to upload or transmit) any material that acts as a passive or active mechanism for collecting or transmitting information, including but not limited to graphics exchange formats ("gifs"), 1 × 1 pixels, web bugs, cookies ... or other similar devices (sometimes called "spyware", "passive information gathering mechanisms" or "pcms"). Except when If this cannot be the result of using standard search engines or an Internet browser. Develop or distribute any automated systems, including any robots, fraudulent utilities, parsers or standalone readers that access the Site and smart contracts, and use or run any unauthorized script or other software. Discredit, defile or otherwise harm us and / or the Site and Smart Contracts. Use the Site and Smart Contracts in a manner inconsistent with any applicable law or regulation.

5. CHILDREN

You affirm that you are over the age of 13, as the App is not intended for children under 13. IF YOU ARE 13 OR OLDER BUT UNDER THE AGE OF 18, OR THE LEGAL AGE OF MAJORITY WHERE YOU RESIDE IF THAT JURISDICTION HAS AN OLDER AGE OF MAJORITY, THEN YOU AGREE TO REVIEW THESE TERMS WITH YOUR PARENT OR GUARDIAN TO MAKE SURE THAT BOTH YOU AND YOUR PARENT OR GUARDIAN UNDERSTAND AND AGREE TO THESE TERMS. YOU AGREE TO HAVE YOUR PARENT OR GUARDIAN REVIEW AND ACCEPT THESE TERMS ON YOUR BEHALF. IF YOU ARE A PARENT OR GUARDIAN AGREEING TO THE TERMS FOR THE BENEFIT OF A CHILD OVER 13, THEN YOU AGREE TO AND ACCEPT FULL RESPONSIBILITY FOR THAT CHILD'S USE OF THE APP, INCLUDING ALL FINANCIAL CHARGES AND LEGAL LIABILITY THAT HE OR SHE MAY INCUR.

6. USER'S OBLIGATIONS

- A User cannot create several player accounts simultaneously, but a User can have one account per every game world. A User cannot provide access to his/her game account to third parties. Using multi-accounts will be punished by blocking the account. A violator will lose all his in-game possessions in favor of the NFT Panda World of Fantasy. To prevent suspicion in the multi-accounts violation a Users should not use the same gadgets with other players.
- Using the website under the NFT Panda World of Fantasy operations, a User agrees to follow the applied rules and conditions. More than that, a User cannot undertake the following actions:
 - Communicate or use the words in the offensive, frustrating, violent, pornographic, racist, or any other immoral or forbidden manner (this includes all the game markers such as player's name, the name of plot, the name of the union, the name of the worker, etc.)
 - Tease, threaten, offend, harass, bespeak, bully other Users
 - Spread the advertising, religious, or political messages (this includes all the game markers such as player's name, the name of plot, the name of the union, the name of the worker, etc.)
 - Announce, spread or pass personal or secret information about other Users or NFT Panda World of Fantasy team, or in any other manner interfere with the private life of other Users or team.
 - Spread the assertions or gossips about the race, religion, gender, social status, orientation, etc. of other Users or NFT Panda World of Fantasy team (this includes all

the game markers such as player's name, the name of plot, the name of the union, the name of the worker, etc.)

- Announce, spread or pass the confidential information about NFT Panda World of Fantasy.
- Spread the false assumptions about NFT Panda World of Fantasy (this includes all the game markers such as the player's name, the name of the plot, the name of the union, the name of the worker, etc.)
- Misrepresent oneself as the NFT Panda World of Fantasy employee, as well as the representative of the partnering or connected company.
- Use images, photos, graphics, video, audio, sounds, texts, brand names, titles, markings, software and any other materials that are protected by the author's rights, without the author's permission.
- Use forbidden or illegal materials.
- Gain the personal/game benefit from the program code mistakes.
- Undertake the actions that can lead to server overload or cause severe problems in the game process.
- Hack the program, call on or indulge such activities.
- Load the files that can contain viruses, Trojans or damaged data.
- Use or spread the automated programs, scripts or other cheating utilities.
- Interfere with the process of data transmission from or into the game servers and website servers.

7. A USER SHALL FOLLOW THE GAME RULES.

NFT Panda World of Fantasy provides the platform for communication between Users. A User alone carries the responsibility for the contents of his/her messages. The platform is intended to be used for game communication only. The use of the platform to spread spam, flood, or any other irrelevant messages is forbidden. The game and game worlds are created for entertainment and should cause positive emotions only. NFT Panda World of Fantasy reserves the right to use specific programs and trained personnel to detect any violations of the rules and identify a User in case of a grounded suspicion of the Agreement violation. The violation of any rules and obligations can be punished by the immediate temporary blocking or deletion of the game account, depending on the severity of the violation. In the case of detecting the breach, the NFT Panda World of Fantasy representative will investigate the consequences of such violation in every separate case. A User acknowledges that the representative's decision is definite. Additionally, a User acknowledges that NFT Panda World of Fantasy cannot reveal the mechanisms it uses to detect violations since they can

be easily circumvented otherwise. NFT Panda World of Fantasy reserves the right to forbid the subsequent registration in the game after the blocking or deletion of the game account on other game servers.

8. APP ERRORS

A User shall report the errors detected in the game immediately. A User cannot demand to save or reverse the game situation or his/her achievements in case of game or website errors. A User cannot demand the 24/7 availability of the game (i.e., in case of situations like technical works on the server).

9. OBSCURATION OF RESPONSIBILITY

NFT Panda World of Fantasy uses third party software such as EOS.IO, WAX Cloud Wallet. NFT Panda World of Fantasy does not hold the responsibility for the third-party software.

10. DISCLAIMERS

A. YOU EXPRESSLY UNDERSTAND AND AGREE THAT YOUR ACCESS TO AND USE OF THE APP IS AT YOUR SOLE RISK, AND THAT THE APP IS PROVIDED "AS IS" AND "AS AVAILABLE" WITHOUT WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, WE, OUR SUBSIDIARIES, AFFILIATES, AND LICENSORS DO NOT REPRESENT OR WARRANT TO YOU THAT: (I) YOUR ACCESS TO OR USE OF THE APP WILL MEET YOUR REQUIREMENTS, (II) YOUR ACCESS TO OR USE OF THE APP WILL BE UNINTERRUPTED, TIMELY, SECURE OR FREE FROM ERROR, (III) USAGE DATA PROVIDED THROUGH THE APP WILL BE ACCURATE, (III) THE APP OR ANY CONTENT, SERVICES, OR FEATURES MADE AVAILABLE ON OR THROUGH THE APP ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS, OR (IV) THAT ANY DATA THAT YOU DISCLOSE WHEN YOU USE THE APP WILL BE SECURE. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES IN CONTRACTS WITH CONSUMERS, SO SOME OR ALL OF THE ABOVE EXCLUSIONS MAY NOT APPLY TO YOU.

WE WILL NOT BE RESPONSIBLE OR LIABLE TO YOU FOR ANY LOSSES YOU INCUR AS THE RESULT OF YOUR USE OF THE WAX BLOCKCHAIN OR THE WAX CLOUD WALLET ELECTRONIC WALLET, INCLUDING BUT NOT LIMITED TO ANY LOSSES, DAMAGES OR CLAIMS ARISING FROM: (i) USER ERROR, SUCH AS FORGOTTEN PASSWORDS OR INCORRECTLY CONSTRUED SMART CONTRACTS OR OTHER TRANSACTIONS; (ii) SERVER FAILURE OR DATA LOSS; (iii) CORRUPTED WALLET FILES; OR (iv) UNAUTHORIZED ACCESS OR ACTIVITIES BY THIRD PARTIES, INCLUDING BUT NOT LIMITED TO THE USE OF VIRUSES, PHISHING, BRUTEFORCING OR OTHER MEANS OF ATTACK AGAINST THE APP, WAX BLOCKCHAIN OR THE WAX CLOUD WALLET ELECTRONIC WALLET

D. NFT PANDA WORLD OF FANTASY ARE INTANGIBLE DIGITAL ASSETS THAT EXIST ONLY BY VIRTUE OF THE OWNERSHIP RECORD MAINTAINED IN THE WAX BLOCKCHAIN. ALL SMART CONTRACTS ARE CONDUCTED AND OCCUR ON THE DECENTRALIZED PLATFORM WAX BLOCKCHAIN. WE HAVE NO CONTROL OVER AND MAKE NO GUARANTEES OR PROMISES WITH RESPECT TO SMART CONTRACTS.

E. NFT PANDA TEAM IS NOT RESPONSIBLE FOR LOSSES DUE TO BLOCKCHAINS OR ANY OTHER FEATURES OF THE WAX BLOCKCHAIN OR THE WAX CLOUD WALLET ELECTRONIC WALLET, INCLUDING BUT NOT LIMITED TO LATE REPORT BY DEVELOPERS OR REPRESENTATIVES (OR NO REPORT AT ALL) OF ANY ISSUES WITH THE BLOCKCHAIN SUPPORTING THE WAX BLOCKCHAIN, INCLUDING FORKS, TECHNICAL NODE ISSUES, OR ANY OTHER ISSUES HAVING FUND LOSSES AS A RESULT.

11. ASSUMPTION OF RISK

You accept and acknowledge each of the following:

A. The prices of blockchain assets are extremely volatile. Fluctuations in the price of other digital assets could materially and adversely affect the value of your NFT Panda World of Fantasy, which may also be subject to significant price volatility. We cannot guarantee that any purchasers of NFT Panda World of Fantasy will not lose money.

B. You are solely responsible for determining what, if any, taxes apply to your NFT Panda World of Fantasy-related transactions. NFT Panda World of Fantasy is not responsible for determining the taxes that apply to your transactions on the App, the Site, or the Smart Contracts.

C. The App does not store, send, or receive NFT Panda World of Fantasy. This is because NFT Panda World of Fantasy exist only by virtue of the ownership record maintained on the App's supporting blockchain in the WAX blockchain. Any transfer of NFT Panda World of Fantasy occurs within the supporting blockchain in the WAX blockchain, and not on the App.

D. There are risks associated with using an Internet-based currency, including, but not limited to, the risk of hardware, software and Internet connections, the risk of malicious software introduction, and the risk that third parties may obtain unauthorized access to

information stored within your wallet. You accept and acknowledge that NFT Panda World of Fantasy will not be responsible for any communication failures, disruptions, errors, distortions or delays you may experience when using the WAX blockchain, however caused.

E. A lack of use or public interest in the creation and development of distributed ecosystems could negatively impact the development of the NFT Panda World of Fantasy ecosystem, and therefore the potential utility or value of NFT Panda World of Fantasy.

F. The regulatory regime governing blockchain technologies, cryptocurrencies, and tokens is uncertain, and new regulations or policies may materially adversely affect the development of the NFT Panda World of Fantasy ecosystem, and therefore the potential utility or value of NFT Panda World of Fantasy.

G. Upgrades in WAX blockchain, a hard fork in the WAX blockchain, or a change in how transactions are confirmed on the WAX blockchain may have unintended, adverse effects on all blockchains using the eosio.token or AtomicAssets NFT Standard.

12. LIMITATION OF LIABILITY

A. YOU UNDERSTAND AND AGREE THAT WE, OUR SUBSIDIARIES, AFFILIATES, AND LICENSORS WILL NOT BE LIABLE TO YOU OR TO ANY THIRD PARTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR EXEMPLARY DAMAGES WHICH YOU MAY INCUR, HOWSOEVER CAUSED AND UNDER ANY THEORY OF LIABILITY, INCLUDING, WITHOUT LIMITATION, ANY LOSS OF PROFITS (WHETHER INCURRED DIRECTLY OR INDIRECTLY), LOSS OF GOODWILL OR BUSINESS REPUTATION, LOSS OF DATA, COST OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES, OR ANY OTHER INTANGIBLE LOSS, EVEN IF WE HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

B. YOU AGREE THAT OUR TOTAL, AGGREGATE LIABILITY TO YOU FOR ANY AND ALL CLAIMS ARISING OUT OF OR RELATING TO THESE TERMS OR YOUR ACCESS TO OR USE OF (OR YOUR INABILITY TO ACCESS OR USE) ANY PORTION OF THE APP, WHETHER IN CONTRACT, TORT, STRICT LIABILITY, OR ANY OTHER LEGAL THEORY, IS LIMITED TO THE GREATER OF (A) THE AMOUNTS YOU ACTUALLY PAID US UNDER THESE TERMS IN THE 12 MONTH PERIOD PRECEDING THE DATE THE CLAIM AROSE, OR (B) \$100.

C. YOU ACKNOWLEDGE AND AGREE THAT WE HAVE MADE THE APP AVAILABLE TO YOU AND ENTERED INTO THESE TERMS IN RELIANCE UPON THE WARRANTY DISCLAIMERS AND LIMITATIONS OF LIABILITY SET FORTH HEREIN, WHICH REFLECT A REASONABLE AND FAIR ALLOCATION OF RISK BETWEEN THE PARTIES AND FORM AN ESSENTIAL BASIS OF THE BARGAIN BETWEEN US. WE WOULD NOT BE ABLE TO PROVIDE THE APP TO YOU WITHOUT THESE LIMITATIONS.

14. CHANGES TO THE TERMS

We may make changes to the Terms from time to time. When we make changes, we will make the updated Terms available on the App and update the “Last Updated” date at the beginning of these Terms accordingly. Please check these Terms periodically for changes. Any changes to the Terms will apply on the date that they are made, and your continued access to or use of the App after the Terms have been updated will constitute your binding acceptance of the updates. If you do not agree to any revised Terms, you may not access or use the App.

15. CHANGES TO THE APP

We are constantly innovating the App to help provide the best possible experience. You acknowledge and agree that the form and nature of the App, and any part of it, may change from time to time without prior notice to you, and that we may add new features and change any part of the App at any time without notice.

16 PRIVACY POLICY

Our Privacy Policy describes the ways we collect, use, store and disclose your personal information, and is hereby incorporated by this reference into these Terms. You agree to the collection, use, storage, and disclosure of your data in accordance with our Privacy Policy.

17. GENERAL

These Terms constitute the entire legal agreement between you and Provider, govern your access to and use of the App, and completely replace any prior or contemporaneous agreements between the parties related to your access to or use of the App, whether oral or written. There are no third party beneficiaries to these Terms. The parties are independent contractors, and nothing in these Terms create any agency, partnership, or joint venture. The language in these Terms will be interpreted as to its fair meaning, and not strictly for or against any party. You may not assign any or your rights or obligations under these Terms, whether by operation of law or otherwise, without our prior written consent. We may assign our rights and obligations under these Terms in our sole discretion to an affiliate, or in connection with an acquisition, sale or merger. Should any part of these Terms be held invalid or unenforceable, that portion shall be construed consistent with applicable law and the remaining portions will remain in full force and effect. Our failure to enforce any provision of these Terms will not be deemed a waiver of such provision, nor of the right to enforce such provision.
